Despite Barahona case concerns, liability limits for foster care agencies advances in House

TALLAHASSEE — A measure capping legal damages for agencies providing foster care services cleared a House committee on an 11-4 vote Wednesday, despite emotional testimony from opponents who said lawmakers are putting dollars ahead of the safety of children in a troubled system.

But House sponsor Scott Plakon, R-Longwood, said his proposal (HB 1019) is aimed at helping agencies better serve children, by lowering insurance costs he says spike because of "frivolous lawsuits."

"It's clear, there is a problem with the rates going up," Plakon told the House Human Services Access subcommittee. "Even if they don't do anything wrong, it's only a matter of time before they'll get sued."

But critics derided the legislation, coming only a month after the death of 10-year-old Nubia Barahona and near death of her twin brother, Victor. The twin's adoptive parents are charged in the beating death of Nubia, whose body police found in a garbage bag in her father's truck on Interstate 95 in West Palm Beach.

Her brother, found in the front seat, had been scalded with toxic chemicals. They had been in foster care with the Barahonas before being adopted by the couple. proceedings in Miami. Her husband Jorge Barahona and two children, Victor and Nubia Barahona, were found covered in chemicals inside a truck alongside Interstate 95 in Palm Beach County in Florida. Nubia was found dead wrapped in plastic. Carmen Barahona was arrested in the death of Nubia, the Miami-Dade Police Department announced nearly three weeks after the girl was found. The state's Department of Children & Families acknowledges the tragedy stemmed from systemic failures within the agency and a private organization, Our Kids of Miami-Dade/Monroe Inc., which handled their adoption and could be shielded from more costly liability under the legislation.

"This legislation is not in the public's interest," said Thomas Bates, a child advocate from Monticello who was raised in foster care. "It decreases the rights of foster children and it allows agencies to escape responsibility."

Committee Chair Gayle Harrell, R-Stuart, said Plakon's prospects for passing the bill became "even more challenging," with the still unfolding case, which has led to firings and suspensions of key personnel within DCF.

"But I think you are on the right track," Harrell told Plakon.

Plakon's proposal would cap financial awards for pain and suffering at between \$200,000 and \$1 million, and would limit economic damages at \$2 million.

Sen. Jack Latvala, R-St. Petersburg, is sponsoring a similar bill (SB 1500). The bills also would lower the amount of liability insurance the agencies must carry from \$1 million to \$500,000.

The measures also would hold DCF harmless from lawsuits filed against the agencies, which in some cases have topped tens of millions of dollars.

Michael Dolce, a board member for the advocacy organization, Florida's Children First, of Coral Springs, said Florida Republican lawmakers were looking to diminish the role of trial lawyers, usually Democratic allies, by making it less lucrative to sue agencies on behalf of abused children.

"They're trying to impose tort reform on the backs of foster children," Dolce said.

But Plakon said he's heard from dozens of agencies facing annual insurance premium increases -- some surpassing 100 percent. Lawsuits are driving the increases, he said.

"I've spent a lot of time with these agencies," Plakon said. "I find them with a pure heart to help childrenbut in the best cases, they take a bad situation and make it better. But every now and again, one of those bad situations go way wrong, through no fault of their own."

The Barahona case hung heavy over Wednesday's debate.
