A Welcome From Our Executive Director

Dear Supporters,

Helen Keller famously said "alone we can do so little; together we can do so much." This past year has illustrated just how much we can make a difference in the lives of children when we all work together.

After reaching our 20-year milestone in 2022, we began 2023 by embarking on an intensive strategic planning process to provide a long-term roadmap for the years to come. The final Strategic Plan report outlines innovative and exciting ways to continue growing and adapting to the evolving needs of Florida's children. Partners, sponsors, supporters, colleagues, and friends came together to offer their input, guidance, and expertise. Their efforts resulted in a bold blueprint ensuring the health, sustainability, and impact of the organization for the future. Many priorities have already been achieved during 2023, which you will read about in the pages that follow.

Highlights include:

Capacity Building

One of the most exciting highlights of the year was expanding our capacity to reach more youth in need. To better meet our mission, provide a stronger platform for youth voices to be heard, and remain a potent force for child advocacy for decades to come, we created two new positions and welcomed two new incredible additions

to our team: Staff Attorney, C. Christine
Smith, and Florida Youth SHINE Community
Engagement Manager, Kaya Lee. With their
extensive experience they hit the ground running
and have already made significant contributions,
including offering legal representation to a
limited number of children and expanding our
Florida Youth SHINE chapter network.

Resource Development

Committed to equipping youth and professionals with the knowledge to be advocates and champions for protecting the rights of Florida's children, a record **12 new publications** and resources were created this past year. Additionally, a **new website**, that was under development in 2023, will soon make our entire resource library easier to access and utilize. It will also allow us to update publications and fact sheets as needed to keep them accurate and relevant.

Education & Training

Dedicated to providing free, accessible training to industry professionals to equip them with the knowledge they need to be strong champions and advocates for Florida's children, we reached record numbers of people through our training workshop series on topical issues, integrating youth experience and perspective at every juncture.



Elevating Youth Voices

Once again this year, we provided **more than 100 advocacy opportunities** for the voices of the youth themselves to be heard, valued and respected. This included:

- 12+ presentations at forums and conferences throughout Florida, Washington DC, California, and New Mexico.
- 10+ trips youth made to Tallahassee to successfully advocate for the "Education for Youth in Foster Care Bill."

Thank you for your steadfast support and for joining us in our quest to continue putting Florida's children first. Working together, we can and will continue to reach new heights as we endeavor to enlighten, empower and ensure a brighter tomorrow for all Florida's children.

Our Mission


Florida's Children First is a non-profit, nonpartisan, independent advocacy organization committed to protecting and advancing the rights of children and youth impacted by the child welfare, juvenile justice, and disability systems through systemic reform, education, youth voice, and promoting high-quality legal representation.

Our Vision

Florida's laws, policies, and practices respect, prioritize, and protect children and youth impacted by the child welfare, juvenile justice, and disability systems.

Our Work

We impact the lives lives of Florida's children, advocating for their rights and creating an environment where they can soar.



Overview of Organization Programs

For over two decades, Florida's Children First has maintained a commitment to addressing the complex maze of challenges faced by youth, especially those within the dependency system.

Our unique collection of programs has been created to fill voids in the system, complement existing services, and specifically address the needs of this population.

We offer programs that champion the rights and protection of children. Programs that support their journey through the system to independent living. Programs that advocate for and support high-quality legal representation for children to ensure their safety. Programs that drive educational success, enlighten those who work and interact with youth, and provide a platform for impactful youth leadership and empowerment.

Above all, programs are conceived and implemented to reinforce our core belief that every child deserves to be safe, nurtured, housed, and heard.



Professional Training & Workshops

Every year, we offer a new series of free training workshops that keep those who interact or care for youth in the system informed and up-to-date on current issues and changes in benefits, policies, and practices. CLE credits for professionals are provided and sessions are accessible on our website's "resource center" for future reference.



Publications

We produce, update, and distribute free fact sheets, guidebooks, charts, and other informational tools on critical issues industry professionals and youth alike need. Publications are also written and designed to be youth-friendly so youth can better understand the content and access benefits and services. Youth Education & Leadership Training

From leadership and life skills training to empowering self-advocacy, our youth training programs are crafted specifically for the needs of youth in care. Through our innovative Florida Youth SHINE program, which is led by a team with lived experience in the system, youth find an environment that nurtures genuine peer connections and motivates participation. We equip youth with the tools and confidence they need to reach high and become confident, fearless leaders they were born to be.



Florida Dependency Law Center

Through our **FloridaDependencyLaw.org** web portal, we support lawyers who represent all parties in child welfare cases and help build an available pool of probono legal services to assist those in need.



Professional Support

The Florida's Children First team of experts offers guidance, training, technical assistance, and ongoing support for lawyers, judges, case workers, and frontline professionals in the child welfare arena. We keep them abreast of evolving laws, regulations, benefits, and best practices and provide a range of resources and daily troubleshooting.



Information, Brief Advice, and Referrals

Regarded as the "go to" source for information on child welfare issues, programs, benefits, and related topics, Florida's Children First staff and attorneys promptly respond to inquiries submitted via email, phone and our website.



Advocacy Initiatives

Advocacy drives our activities at all levels. On a legislative level, we propose, draft, and comment on new legislation, providing comprehensive documentation on the potential impact of proposed bills. We file amicus briefs to assert children's rights and aid in the appointment of attorneys for them. We also serve as advisors to the Executive branch, offering insights on new rules, and participate on task forces, panels, and forums that shape policy.



High Quality Legal Representation

We provide independent, personalized guidance, brief advice, and quality representation to ensure more youth receive the representation they need and deserve and to be sure they have a voice in the proceedings that shape their lives.



Florida Youth SHINE Program

The award-winning Florida Youth SHINE (FYS) program offers leadership, mentorship, and advocacy opportunities to youth aged 13-26 in the child welfare system and that experienced homelessness. Through leadership training, engagement with positive mentor role models, a curriculum crafted to address their unique needs, and one-of-a-kind opportunities, youth conquer challenges, gain confidence, and emerge as goal-oriented, accomplished young adults. Emboldened by their experiences in Florida Youth SHINE, these young changemakers drive positive change by elevating and amplifying their voices and leading their peers in care.



Florida Youth SHINE Youth Action Hours

Each month, our open forums bring Florida Youth SHINE members and mentors together in a virtual space to process issues, topics, and solutions for local and statewide advocacy needs.



Florida Youth SHINE Local and Statewide Advocacy

Florida Youth SHINE chapters are at the forefront of advocacy, both locally and statewide. At the local level, youth members spearhead training in their communities, fostering public awareness while honing essential life skills and shaping effective solutions. On the statewide front, FYS champions change with youth-led training sessions. Their potent personal narratives and astute recommendations spotlight the challenges faced by youth in care, driving significant improvements throughout the care system.



Florida Youth SHINE Statewide Conference

Florida Youth SHINE members and mentors convene annually in Tallahassee for Children's Week. They engage with legislators and agency officials as they advocate for vital child welfare issues. Prior to each state capitol visit, FYS members undergo intensive training covering teamwork, leadership, public speaking, legislative processes, advocacy skills, and more. Four times a year, Florida Youth SHINE members and mentors also come together for intensive advocacy and leadership workshops. Held around the state, these quarterly meetings allow youth to interact with peers in care from other areas to bond and bring attention to the issues and solutions affecting youth in care.



Florida Youth SHINE Policy & Initiatives Program

Nearly 20 youth meet virtually twice monthly, playing an active role in researching issues, advocacy work, learning the legislative process, and implementing youth-led projects to impact effective policy change. This vital program hones youth leadership and organizing skills.



Florida Youth SHINE Peer Connection Events

Each month, our open forums bring Florida Youth SHINE members and mentors together in a virtual space to process issues, topics, and solutions for local and statewide advocacy needs.

2023 Program Impact

For more than twenty years, Florida's Children First has been here to inform, educate, advocate, legislate, and empower. In 2023, our efforts resulted in profound achievements that significantly impact children, families, and industry professionals, and will help improve long-term outcomes for children who have had a challenging start in life.

Advocacy Impact



12 New Publications created with direct youth input on children's rights and benefits, distributed throughout Florida.



5,948 Individuals trained, including many forums co-led by Florida Youth SHINE sharing their personal experiences in care to offer a candid youth perspective.



28,449 youth this year, and thousands more each year after, will now be educated on the rights and benefits available to them in care with passage of the "Education for Youth in Foster Care" bill.



1823 Pro Bono hours donated to helping children, which equates to \$298,860 in professional services generously donated.



17,500 parents supported by FCF's Florida Dependency Law Center who are current on law and policy and have access to resources to address their specific legal needs.

Florida Youth SHINE Impact



In 2023:

36

36 Youth met with 85 decision makers and testified in 6 legislative committee hearings to successfully advocate for legislation requiring that the state educate youth about existing laws that protect them, charting a new course for youth in care.

250

250 Youth discussed their experiences in foster care, sharing insights on what helped, or could have helped, them thrive. Responses were categorized by FYS' Policy & Initiatives committee and compiled into a comprehensive 16-page policy report and action plan for FYS advocacy priorities.

450

450 Youth previously precluded from getting a driver's license and insurance assistance through the state's driving program for former foster youth are now eligible for that support due to the "fix" we successfully obtained. (SB 272 - 2023)

This offers a glimpse into the transformative milestones and dedicated advocacy that have marked our 22-year journey to ensure every child in Florida is **safe**, **heard**, and has the **opportunity to flourish**.



By Impacting Laws & Policies We Have:

- Secured the option for youth to remain in foster care until age 21.
- Paved the way for FREE in-state college tuition until age 28 for youth from foster care, relative care, or those experiencing homelessness.
- Made obtaining a driver's license and insurance possible for youth in foster care.
- Enhanced youth representation in court decisions.
- Removed barriers to normalcy, allowing participation in activities like sports and sleepovers – becoming a national model.
- Spearheaded laws to support sibling unity.
- Reduced overmedication and unnecessary psychotropic drug prescriptions.
- Fought for rights of sex-trafficked children, ensuring they receive appropriate services.

Standout Moments of 2023

Organizational Growth

Strengthening our small but mighty staff of five to meet the needs of more youth and create greater community impact had long been an organizational goal. In 2023, we proudly added two new staff members to the Florida's Children Family.

Educating Youth in Foster Care Bill Passes in 2023, After 5 years of Florida Youth SHINE Advocacy

A highlight of 2023 was passage of the landmark "Educating Youth in Foster Care Bill" after five years of Florida Youth SHINE advocacy. Though Florida has many great laws to protect and benefit children, it doesn't help them if they are never made aware of them until they have aged out of care. Sadly, it was common flaw in the system that FYS members worked to correct.

Over the years hundreds of Florida Youth SHINE members traveled to Tallahassee to advocate for this legislation. Many testified to legislative committees on the importance of this bill, sharing intimate aspects of their lives with decision-makers to impress on them the urgent need for this knowledge. Many spoke out even though they could no longer benefit from the legislation, to ensure future generations did not miss out on opportunities, as they had.

In 2023, their efforts paid off when SB 272 & HB 1101, The Education for Youth in Foster Care Bill, became law throughout Florida!

What This Bill Does:

- Requires the Department of Children and Families (DCF) to educate foster youth on their rights every six months, in an age-appropriate manner.
- Codifies the Office of Ombudsman as a DCF position, so youth have a safe space to reach out to register complaints when their rights are being breached or they are endangered.

In short, it ensures kids are educated on the laws, and case managers know about them, for improved implementation of laws and rules in place to protect our children.

What This Bill Means:



No kid goes into foster care knowing about the system or what our rights are. It's up to adults to educate us. Sometimes that doesn't happen. Passing a bill educating youth on their rights will help us stay on track to succeed."



Program Expansion: High Quality Direct Legal Representation

Quality legal representation is a fundamental cornerstone of Florida's Children First's mission. Yet, direct representation of youth was not offered despite hundreds of inquiries FCF received each year. That changed in 2023. Adding a staff attorney to team now allows FCF to provide independent, personalized guidance, brief advice, and quality representation to ensure more youth receive the representation they need and deserve. Though Christine Smith, the staff attorney hired to launch the new program joined the team late in 2023, her impact was immediate and impressive. The organization was able to provide advice and counsel to 193 clients, a 370% increase in the limited number of clients we could address the prior year.



#YouthCanSHINEwith Action Campaign

Every 2 years Florida Youth SHINE engages in a "Youth Action Cycle" to determine their top policy objectives to focus on. After surveying over 250 youth statewide for input, the FYS Policy & Initiatives Team (Pi Team), comprised of nearly 20 FYS youth, culled through all the response data. With so many critical issues raised, the Pi Team synthesized all the feedback into a 20-page policy brief of recommendations in 4 key areas that will help youth in care obtain better long-term outcomes. In addition to showcasing youth stories that illustrate why policy change is needed, each focus area offers actionable solutions that do not require legislative change, along with ones that do.

Armed with this bold blueprint for changing children's lives, FYS decided to expand their Youth Action Cycle into a powerful, multi-tier" Youth Voice Action Campaign" called: #YouthCanSHINEwith. The Pi Team shared the report with their peers at meetings statewide and assessions and workshop practitioners throughout the year throughout Florida and nationally.

Since the campaign launched, a remarkable 6 recommendations from the report have been implemented in the inaugural cycle, including a major legislative win with powerful, positive implications for youth in care.



Florida Youth SHINE Educates & Advocates at DCF Statewide Summit

For the annual "Department of Children and Families Summit" in Orlando, 40 FYS members attended and 7 presented on a powerful panel entitled "#YouthcanSHINEwith Your Help! A Youth-led Action Session by Florida Youth SHINE" focused on ways child welfare professionals can help youth truly shine. FYS also had a breakfast with DCF leadership, discussing needs and priorities in a more intimate setting. Several youth on panel were featured on Orlando news station, WFTV 9, showcasing their advocacy journey.

Youth Honored in 2023

The annual "Outstanding Advocates for Children Awards" fundraisers once again celebrated the remarkable contributions to the well-being of children being made by some of Florida's most passionate and dedicated child advocates and organizations. Nearly 700 people participated in 5 awards events across Florida, generating more than \$350,000 for the organization. Individuals, non-profits, and companies from around the state were honored along with 6 youths from foster care who were recognized for their resiliency, passion for helping their peers, and courage to lift their voice to improve conditions for future generations of youth in care.

Stories Behind Florida Children's First

Aheim King

Florida Youth SHINE Member

After Aheim's mother struggled with schizophrenia and experienced a mental breakdown, Aheim and his brother were separated and placed into foster care. Aheim required some medical assistance, and he was ultimately placed into relative care with an Aunt. Entering foster care, he said, felt "like being dumped into another world."

When Aheim turned 18, he was still in his senior year of high school. While his Aunt allowed him to stay with her until he went off to college, he had to pay her rent. Now technically, out of the system and on his own, he struggled to cover rent and transportation. He worked two jobs while trying to maintain his GPA, lost sleep and the juggling act added enormous stress.

Aheim's Independent Living Director and other mentors introduced him to other youth in foster care going through similar experiences. They encouraged him to participate in Florida Youth SHINE and there, he found another family of sorts with his peers in foster care. He found an outlet to open up about challenges he was facing in care, a support system that could help him address them, and a passion for advocating for himself and for others.

Aheim shared his story with decision makers when Florida Youth SHINE visited the Capitol during Children's Week. In addition to preparing his own talking points for these meetings, Aheim spent time helping other FYS members write and fine-tune their presentations for Children's Week to advocate for a key bill, participate in a DCF



workshop to explain the findings in the "YouthCanSHINEwith" Policy Report, and was featured in an Orlando TV news story on FYS advocacy.

"In Florida Youth SHINE I discovered peers who wrestled with emotions when facing judges, as I did when asked to speak out about my mother or living in the system. Many of my peers were also moved around to multiple placements. While I was fortunate to be reconnected with my siblings, many of my peers, I learned, were not as lucky. FYS helped me realize how fortunate I was in many ways, so I was glad to have the chance to speak out on these issues, using my voice to advocate for systemic change to help improve the system and change things for other youth."

Georgina Rodriguez

FCF Board Director & FYS Alumni

Georgina Rodriguez has spent her professional life immersed in child welfare issues. She has held roles in direct service, direct care, or direct support in Florida's child protection system for the last 15 years. She has held roles in Dependency Case Management, Independent Living Services, direct care in residential group homes, law enforcement, homeless services, and administrative support within CBC agencies and Children's Legal Services on behalf of DCF. Currently, she works as an analyst to prevent child sexual exploitation and safeguard children from harm.

But her expertise in the child protection arena runs deep. You see, Georgina spent 12 years in Florida's foster care system where she experienced hardship and maltreatment, was separated from her brother, and lived in nine different foster care placements. Upon aging out of care at 18, she was determined to build a life she could be proud of— one filled with love, healing, passion, and purpose.

Today, she has fulfilled her dream of becoming a social worker, giving back to the community, and impacting lives by serving children and families. Her resiliency comes from her faith in God and those who have supported her along the way. She credits Florida's Children First, and years spent as an active Florida Youth SHINE member, for her commitment to child advocacy and being a champion for the voiceless.

In Florida Youth SHINE, Georgina rose from Chapter Representative to Legislative Chair to Statewide Chair. She bravely shared her lived experiences with stakeholders in industry workshops to better educate and train child welfare professionals. She met with legislators and testified numerous times on behalf of legislation to improve the foster care system for future generations of children and families.



Indeed, she helped steer passage of some of the most groundbreaking bills and laws FYS ever championed, including the landmark "Normalcy" bill. In Washington D.C. she provided research, analysis, and direct experience on child welfare issues and testified in Congress, offering recommendations for enhancing child welfare systems across America.

Along the way, Georgina has encountered a "family" of caring individuals, positive role models, and supportive peers. Now in a position to ensure more youth like herself continue to benefit from all Florida Youth SHINE and FCF offer, she has stepped up to serve on Florida's Children First Board of Directors.

"When I found Florida Youth SHINE (FYS), there were no other groups of youth in foster care making the impact that FYS does. In a system where youth were once dismissed, FYS created a space where their voices are heard and decisions are made with them in mind. For over 20 years, FYS has led the way, making youth advocacy the norm. Their dedication inspired me to join the board of Florida's Children First, and I am honored to use my experiences to help protect Florida's most vulnerable children."

When FosterPower, a statewide movement to improve the lives and futures of youth in care was in the process of creating a unique, youth-friendly app and website that consolidates all the information on benefits, protections, and legal rights available to youth in one place, they needed feedback from the primary user base: The youth actually in foster care.

To obtain that input, they reached out to collaborate with Florida Youth SHINE. As Florida's premier child advocacy and youth

voice organization for youth in the child welfare system, it was a natural choice. The organization was well-known for providing incisive input, candor, and professionalism. Foster Power's founder Taylor Sartor, expanded on her experiences working with Florida Youth SHINE and the value they brought to the project:

"Florida Youth Shine has been instrumental in ensuring youth voice is at the forefront of FosterPower. We held two user research sessions with FYS members to discuss their thoughts and opinions surrounding what type of information they would like to see in the app. Their feedback was pivotal in the overall design, content, and language of the final product. They even provided line-by-line feedback on specific sections. FYS members were also featured in our "FosterPower Youth Video Series" showcasing former foster youth who discuss their own experiences in foster care. As the first app of its kind in the state and the country, we have done presentations and trainings on the FosterPower app locally and nationally on the Florida Bar News, Stetson Law News, LawNext, LSC Law and Justice Podcast, the ABA, Annie E. Casey Foundation blog, and NPR, to name a few. Florida Youth SHINE has participated in many of these interviews."


